

# SEDP MBA 9<sup>th</sup> ANNUAL GENERAL MEETING

SEDP SOCIAL HALL 4<sup>th</sup> Floor, The Chancery, Cathedral Compound Albay District, Legazpi City December 2, 2017, 9:00 AM

The 2017 SEDP MBA Annual General Membership Meeting comprised of two parts:

Part I	-	Advocacy Forum ( Morning)
Part II	-	Business Meeting (Afternoon)

The program started at 9:14 in the morning with an opening prayer led by the emcee, Ms. Noemi Bonaobra, after which the roll call of attendance per area followed. A welcome address was delivered by the BOT-Vice President, Ms. Remegia Balucio. She gave emphasis on the importance of conducting an Annual General Membership Meeting which is to provide update to the clients about the Operations Highlights of SEDP MBA for the year 2017. Ms. Balucio also highlighted the per area gathering of SEDP Inc. wherein each member with outstanding performances were given appreciation during the program. Ms. Balucio relayed that during one of the assemblies of SEDP a priest said that SEDP Inc. is ''namumulaklak at namumunga'', which means that SEDP Inc. is growing bigger and better because of the value added services like the SSS, MBA and MPC including all the existing benefits which were given to the members. A member shared the benefit she had received like the lowering of Service Fee from 3% to 2%. Also one member shared the benefit she had received like the ''Lamay Package''. Ms. Balucio point out the meaning of "SEDP Inc. is namumulaklak" which means that SEDP Inc. has an overflowing benefit for the members, as well as SEDP MBA has been managed very well both in Operations and Finance, and hopefully she added that this Annual General Membership Meeting would bring a fruitful result.

The emcee highlighted that today the National Winner for the Best Microentrepreneur in the Philippines will be introduced, including her success story on how she pursued in her life to become successful, wherein she is one of the member of SEDP Inc.

Mr. Roberto A. Dalit, the SEDP MBA Manager discussed the SEDP MBA Anti-Fraud Plan. As per Insurance Commission Circular 2016-50, the Anti-Fraud plan should be developed and in-placed by Mutual Benefit Associations as a means of insurance fraud prevention, detection and mitigation.

The Anti-fraud plan discussions were as follows:

Fraud is defined as the intentional distortion of truth in order to induce another party.

SEDP MBA does not tolerate fraud, whether carried out by the members or by nonmembers, trustees, management and staff of SEDP MBA or by the microfinance and organized groups partners or supplier.

Purpose of Anti-Fraud Plan

- Define the procedures involved in preventing, detecting, reporting and investigating suspected or actual cases of fraud involving members, intermediaries and internal staff in the areas of membership enrollment, collection of contributions, claims and handling of assets.
- Identify the member of Board of Trustees, tasked with oversight responsibility over the anti-fraud plan.



Oversight and Operational Responsibilities over the Anti-Fraud

• The Compliance Officer is designated by the Board of Trustees as the Anti-Fraud Officer.

Mr. Dalit asked the members on how they screened the in-coming members? One member said that prior to recruitment of new member they asked them first if they have any illnesses or none. Another member said that they asked the in-coming member if they have the capacity to work or do business.

Mr. Dalit emphasized that the Community Development Worker (CDW) need to screen very well the correctness of all the information in the submitted documents of the members like the birth certificate etc.

A member asked what happen if the member died and the stated beneficiary is already married, can he or she still avail the benefit? Mr. Dalit clarified that though a beneficiary is already married he or she can still claim the benefit for the deceased.

One member still asked if the member had a legal spouse but he/she had already a live-in partner, who will receive the benefit? Mr. Dalit said that the legal spouse had the right to claim the benefit because he/she is the one stated in the marriage contract.

A member suggested increasing the amount of Daily Hospitalization Income Benefit (DHIB) because it is not enough to cover the medical expenses. Mr. Dalit explained that the purpose of DHIB is only to cover the daily income miss out by the member during his/her confinement.

After the discussion, Ms. Bonaobra asked the members if what they have understood about the SEDP MBA Anti-fraud plan as discussed. A member said that fraud is all about dishonesty. Another said that fraud means receiving a benefit that is not intended for you. Further, Ms. Bonaobra emphasized that SEDP MBA and SEDP Inc. is strictly implementing the zero tolerance on fraud. The Management is protecting SEDP MBA and SEDP Inc. against fraud.

On the other hand, one member asked if a member can avail a benefit in case of suicide cause of death? Mr. Dalit explained that if a member committed suicide, he/she can receive a benefit if he/she is already one year in membership.

# SEDP MPC SOCIAL PROTECTION SERVICES

Mr. Johnas Allen Mendoza, Marketing Manager discussed about the SEDP MPC Social Protection Program.

The SSS is promoting social protection to those who would like to become member of it.

Being a member of SSS is very important for the member and their family in order to be prepared for the future against sickness and untoward accident. SSS Benefit:

- Maternity
- Disability
- Retirement
- Death and Funeral Grant



Mr. Mendoza discussed the SSS membership process and the needed requirements to become a member.

Mr. Mendoza also introduced the SEDP Care ''Sagot Kita Hangang Langit''. The SEDP Care Program is launched as its eternal care for the members in collaboration with SEDP Inc., SEDP MBA and SEDP MPC. Mr. Mendoza explained the requirements together with the benefits that a member can avail which include Funeral Services to members' death.

The Marketing Consultant, Ms. Ruby Mendones Macasinag facilitated the conduct of KAP survey.

# A. INVOCATION

The Annual General Meeting started with a video clip invocation at 1:15 in the afternoon. After which, the Internal Audit of SEDP Inc. was appointed as an Independent Party to count and validate the votes of AGMM proceedings.

# B. APPOINTMENT OF INTERNAL AUDITOR AS INDEPENDENT PARTY TO COUNT AND VALIDATE THE VOTES OF AGM PROCEEDINGS

Since the welcome remarks was done in the morning, Fr. # AGM RESOLUTION NO. 4 Series of 2017

### ACCEPTANCE OF OPERATIONS AND FINANCIAL REPORT

RESOLVED, as it is hereby resolved that the General Membership of SEDP MBA with 149 votes accepted the Operations and Financial Report.

### SEDP MBA BY LAWS PROPOSED AMENDMENTS

It was presented by Mr. Roberto Dalit, the SEDP MBA Manager.

The proposed amendments for SEDP MBA By Laws were as follows:

Section 1 – That the purpose for which SEDP MBA is formed is to advance the interests and promote the welfare of the Filipino faithful who belong to the financially disadvantaged sector of the society in particular and the interest and welfare of the Philippines in general.



ARTICLE III Section 1. Additional Provision

C. Those persons occupying the following titles and positions in the Diocese of Legazpi, during their incumbency, shall be considered as automatic and honorary members of the association:

- The Bishop;
- The Vicar(s) General; and
- The Vicars Forane of the three vicariates;

Section 2. Rights of Members – A member shall have the following rights:

- To vote on all matters relating to the affairs of the SEDP MBA;
- To be present and to participate in the deliberations of the SEDP MBA;
- To avail of all the facilities of the SEDP MBA upon proper approval of the duly authorized officer;
- To examine and inspect the records and books of the SEDP MBA during business hours, provided, however, that any and all information therefrom shall be treated as privileged and can not be used against the SEDP MBA, otherwise, the member may be refused of this right.

### Section 3. Notice of Meeting

Notices for special meetings may be made by written notice delivered personally, or by email, at least five (5) days before the meeting. The written notice shall contain the particular matters to be discussed. Only matters specified in the notice of special meeting can be the subject of motions or deliberations at such meetings.

### Section 4. Quorum

In all regular or special meeting of members, at least fifty percent (50%) of the general membership of good standing plus one (1) must be present or represented by proxy in order to constitute a quorum provided that all area of coverage are well represented. A member may be represented by a proxy, through a written notice to the Secretary. The authorization shall be valid only on the date of the meeting indicated thereon. If no quorum is constituted, the meeting shall be adjourned until the requisite number of members shall be present.

### Section 5. Conduct of Meeting

Meetings of the members shall be presided over by the President, or in his absence the Vice-President or in the absence of the Vice-President, members of the Board of Trustees present at the meeting may appoint from among them the presiding officer. The Secretary shall act as Secretary every meeting or in his absence the presiding officer shall appoint a secretary for that particular meeting.

### Section 7.

The members of the Board shall not receive any salary, as such trustees, but shall be entitled to gratuity, per diem and reimbursement of all necessary expenses incurred on account of attendance n committee and board meetings, however, all the entitlements, benefits, and emoluments other than per diems and reimbursement of incidental expenses may be granted



to the trustees by the vote of the members representing at least a majority of the membership at a regular or special membership meeting.

### ARTICLE V - BOARD OF TRUSTEES

Section 1.

The corporate powers and general management of the corporation shall be exercised, all business conducted and all property of the corporation controlled and held by the Board of Trustees.

Without prejudice to the general powers herein conferred and as may be granted by law, the Board of Trustees shall have the following express powers.

To purchase, receive, take or grant, hold, convey, sell, lease, pledge, mortgage and otherwise deal with such real and personal property, including securities and bonds of other corporations, as the transaction of the lawful business of the corporation may reasonably and necessarily require, subject to the limitations prescribed by law and the Constitution. To invest the funds of SEDP MBA in other corporations or business or of any purpose other than the primary purpose for which the SEDP MBA was organized, provided it is approved by a majority of the Board of Trustees and the intended investment is reasonably necessary to accomplish the primary purpose of SEDP MBA as stated in the Articles of Incorporation.

Additional to corporate powers:

To exercise such other powers as may be essential or necessary to carry out its purpose or purposes as stated in the Articles of Incorporation.

### Section 2.

The Board of Trustees of SEDP MBA shall consists of seven (7) members who are practicing Catholic namely the following: three (3) trustees shall be elected by the active members with existing loans funded by the Simbag sa Pag-Asenso Inc.; two (2) independent trustees, to be elected by the active members and two (2) members, one (1) of whom is appointed by the Simbag sa Pag-Asenso, Inc. and one (1) from SAC appointed by the Bishop of the Diocese of Legazpi;

### Section 4:

The elected members of the Board of Trustees shall serve beginning immediately following their election for a term of three (3) years until their successors shall have been elected. Provided, that no member shall serve as member of the Board of Trustees for more than two (2) consecutive terms.

### Section 5.

The trustee eligible for election/nomination must be of legal age, a recognized active member of SEDP MBA, has consistently performed very satisfactorily for at least the last three (3) years in her/his membership, has an ongoing business/es funded by loan from Simbag sa Pag-Asenso Inc. and is willing to perform the functions of a trustee without remuneration.



ARTICLE XIII – Fund

Members shall be charged contribution per week for Basic Life Insurance Plan as stipulated in the IRR for the payment of death or total and permanent disability of a member or any member's legal spouse, or any of the member's biological and/or legally adopted children, two(2) weeks old but not more than 21 years old and single; or biological children over 21 years old, single but disabled and incapacitated to work, or biological parent of a single (unmarried) member who are below 65 years old in accordance with the attached Table of SEDP MBA Life Insurance Benefits. Credit Life Insurance Plan shall charge 1.5% per annum from every loan approved of Loan Redemption and Refund.

b. MBA shall deduct not more than 20% from the weekly premium contribution of its members for Basic Life Insurance and not more than 35% from the Credit Life Insurance as administrative expenses. The remaining 80% of the member's weekly contribution shall be used for paying mutual benefits as in accordance with the attached Table of SEDP MBA Life Insurance Benefits while the remaining 65% shall be used for collection fee, guaranty fund and loan redemption and refund.

Prior to approval of amendments, Mr. Dalit asked for any clarifications from among the members.

After the discussion of By Laws proposed amendments, Ms. Cindy Cervano moved to ratify the amendments supported by the majority of 153 votes. The motion was seconded by Ms. Teresita Abling.
