

- 2. That SEDP MBA is a non-stock, **non-profit** association and the following may become a member of the SEPD MBA:
  - a. all active members of the SEDP-Simbag sa Pag-Asenso, Inc.;
  - b. personnel and staff of SEDP-Simbag sa Pag-Asenso, Inc. and SEDP MBA; and
  - c. other organized groups accredited by SEDP MBA (As amended on December 14, 2014)
- 3. That in case of dissolution of the SEDP MBA, its residual assets after the liabilities and obligations are settled and paid shall be transferred to SEDP-Simbag sa Pag-Asenso, Inc., or by two-thirds (2/3) vote of all its members to another corporation of similar or related purpose. (As amended on December 14, 2014)

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a <u>non-stock</u>, <u>non-profit</u> Mutual Benefit Association (MBA) under the laws of the Republic of the Philippines. (as amended on December 14, 2014)

#### THAT WE HEREBY CERTIFY:

FIRST: The name of the said association shall be:

Simbag & Emer Rensya asin Dagdag Paseguro Mutual Benefit Association (SEDP MBA), Inc.

SECOND: That the purpose for which SEDP MBA is formed is to advance the interests and promote the welfare of the poor in particular and the interest and welfare of the Philippines in general. Specifically SEDP MBA shall seek:

- 1. To extend financial assistance to its members, spouse, siblings, children and parents in the form of death benefits, sickness benefits, provident savings and loan redemption assistance;
- 2. To ensure continued access to benefits/resources by actively involving the members in the management of the association that will include implementation of policies and procedures geared towards sustainability and improved services.

THIRD: That the place where the principal office of the SEDP MBA is to be established or located is at:

2<sup>nd</sup> Floor Social Action Center Building Cathedral Compound, Albay District 4500 Legazpi City, Albay

FOURTH: That the term for which the SEDP MBA is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.

EIGHTH: That SEDP MBA is a non-stock, <u>non-profit</u> association and the following may become a member of the SEPD MBA:

- a. all active members of the SEDP-Simbag sa Pag-Asenso, Inc.;
- b. personnel and staff of SEDP-Simbag sa Pag-Asenso, Inc. and SEDP MBA; and
- c. other organized groups accredited by SEDP MBA.

(as amended on December 14, 2014)

NINTH: That no part of the income which the SEDP MBA may obtain as an incident to its operation shall be distributed as dividends to its members, trustees or officers subject to the provisions of the Corporation Code on dissolution. Any profit obtained by SEDP MBA as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provisions of Title XI of the Corporation Code of the Philippines.

TENTH: That Mrs. Preciosa E. Belleza has been elected by the members as Treasurer of the SEDP MBA to act as such until her successor is duly elected and qualified in accordance with the by-laws and that as such Treasurer she has been authorized to receive for and in the name and for the benefit of the SEDP MBA all contributions or donations paid or given by the members.

ELEVENTH: That Simbag sa Emerhensya sin Dagdag Paseguro in *English* means Emergency Response through enhanced Insurance Benefits. That the SEDP MBA manifests its willingness to change its corporate name in the event another person, firm or entity has acquired a prior right to use the said firm name or one deceptively or confusingly similar to it.

TWELFTH: That the SEDP MBA shall comply with the requirements for non-stock corporations in the course of its operation.

THIRTEENTH: That in case of dissolution of the SEDP MBA, its residual assets after the liabilities and obligations are settled and paid shall be transferred to SEDP — Simbag sa Pag-Asenso, Inc., or by two-thirds (2/3) vote of all its members to another corporation of similar or related purpose. (as amended on December 14, 2014)
